OTC drugs & medicines "eligible" without a prescription

The Coronavirus Aid, Relief, and Economic Security (CARES) Act was recently signed by President Donald Trump. As part of the new legislation, below are two updates that may benefit you.

- 1. You no longer need a prescription from your physician when using your PayFlex funds to pay/get reimbursed for over-the-counter (OTC) drugs and medicines. Such items include allergy medicine, cold medicine, pain relievers, etc.
- 2. Feminine hygiene products are now part of the list of eligible over-the-counter items.

These changes are effective for any eligible OTC drugs and medicines incurred after December 31, 2019 – as long as OTC items are allowed under your plan. There's no expiration date for these provisions.

Using your PayFlex funds to pay for OTC drugs and medicines

- **To submit eligible OTC drugs and medicines for reimbursement**: <u>Log into **payflex.com**</u> or your PayFlex member website. You can also log into the PayFlex Mobile[®] app.
- If you have a PayFlex debit card:
 - Allow time for the debit card system to update. PayFlex doesn't manage this process.
 - If your PayFlex debit card doesn't work at time of purchase, you can pay out of pocket, and request reimbursement from your PayFlex account funds (see above).
